Declared Value of Prize(s): One (1) Grand Prize will be awarded, consisting of Round-trip air transportation on Southwest Airlines for two (2) to either Oakland, CA, or San Francisco, CA, or Sacramento, CA (the "Destination") departing from the major commercial airport served by Southwest Airlines in the continental United States, closest to the winner's primary residence, as determined by Live in the Vineyard and the Participating Radio Station(s). If Contest winner resides within 300 miles of the Destination where Southwest Airline flights are not an option, the winner will be responsible for transportation to the event and prize pack taxation will be adjusted accordingly; Three (3) nights luxury hotel accommodations at the Napa River Inn (one double occupancy room and room tax only) for winners considered by Live in the Vineyard (LITV)(Sponsor) to be on the "East Coast; Two (2) exclusive tickets for multiple private acoustic concerts throughout the event which, as of the posting of these Official Rules prior to the start of the Entry Period is expected to include 10+ artists in Napa Valley, CA on November 1st, 2nd and 3rd, 2019; Two (2) passes to the Sunday Send-off Brunch Event with brunch and special programming.
